S.O. -63 Dated 18th AUGUST, 2017--In exercise of the powers conferred by sub-section (1) of section 9 of the Jharkhand Goods and Services Tax Act, 2017 (12 of 2017), the State Government, on the recommendations of the Council, hereby makes the following further amendment in the notification of the Commercial Taxes Department, Jharkhand, No.1/2017-State Tax (Rate), dated the 29th June, 2017 published in the Jharkhand Gazette, Extraordinary *vide* S.O. 31 dated the 29th June, 2017, namely:-
