No. 706/2017.**—In exercise of the powers conferred by sub-section (1) of section 9 of the Kerala State Goods and Services Tax Act, 2017 (20 of 2017), the Government of Kerala, on the recommendations of the Council, hereby makes the following further amendment to the notification issued under G. O. (P) No. 62/2017/TAXES dated 30th June, 2017 and published as S. R. O. No. 360/2017 in the Kerala Gazette Extraordinary No. 1350 dated 30th June, 2017, namely:—

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government, on the recommendation of the Council (Goods and Services Tax Council) have decided to reduce the State tax on tractor parts to 9 per cent. The Central Government have also reduced the tax rate on the same as per their notification No. 19/2017-Central tax (Rate) dated 18th August, 2017.

The notification is intended to achieve the above object.
