No.329/2017 – In exercise of the powers conferred by sub-section (1) of section 9 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following amendments, in the notification of the Government of Odisha, in the Finance Department No.19829-FIN-CT1-TAX-0022-2017 published in the Extraordinary issue No.1133 of the *Odisha Gazette* dated the 29th June, 2017, bearing SRO number 295/2017, namely:-

In the said notification,-

- (1) In Schedule I- 2.5%,

- (i) after Serial No.16, the following serial number with its entries shall be inserted under the appropriate columns, namely:-
